In this verification process, we will be comparing information from your financial aid application with signed copies of your and your spouse's (for students who are married) or your parent(s)' (for dependent students) 2008 federal income tax returns, schedules, and W-2 forms or other financial documents. By law, we have the right to ask you for this information before awarding federal aid. We must review the requested information under the federal financial aid program rules (CFR Title 34, Part 668). If there are differences between your application information and the verification documents, we will make the corrections and send the required changes electronically to the federal student aid processor, to have your information reprocessed.

What you should do

1. Collect signed copies of your and your parent(s)' 2008 federal income tax returns, schedules, and W-2 forms. If you need to request a copy of your tax return, call the IRS at 1-800-829-1040.
2. Read the instructions carefully and complete and sign this form. Do not leave questions blank.
3. Mail this completed form and any other documents that we have requested to The College Board Institutional Documentation Service (IDOC) with the IDOC Cover Sheet. You will receive the Cover Sheet with instructions and the mailing address after February 3, 2009.
