Over the past few years we have also been actively promoting the formation and now the development of an Endowed Legacy Fund to stand as a perpetual gift to Wellesley from The Class of 1960.

As of the current fiscal year, which ends on June 30th, 2016, this Legacy Fund has grown to \$206,854. Dr. Banzaert is very grateful that this has enabled her to take students in January for hands on experience to a Guatamalan village with technology they have learned in the Wellesley Engineering Lab. Also, because we have been so generous, it will enable a student to do additional summer research.
