**Permission is granted under the following conditions:**

1. Permission applies only to this specific request and is limited to this one use. Permission for any future editions, different publisher imprints, translations or ancillary projects or must be requested in writing and approved by the museum in advance are subject to re-use fees. Reproduction rights are not transferable to a third party unless other stated in writing.
2. Those requesting permission to use photographs must assume responsibility of ascertaining copyright ownership of certain works of art and compliance with the pertinent copyright restrictions. The Museum assumes no responsibility for claims against the applicants or the Museum by third parties (including the artists, their agents or estates) and applicants agree to indemnify the Museum and hold it harmless against any and all such claims and cost, including copyright infringement claims arising out of applicant's reproduction of the work(s) of art in question. The Museum will not grant an exclusive right to reproduce any work(s) of art in the Museum; nor will the Museum assume any responsibility for reproduction of the same work(s) of art by any other party.
3. Reproductions are permitted only from photographs or transparencies supplied by the Davis Museum. Applicants will be responsible for the return of rented materials upon completion of the project for which permission has been obtained. Any unauthorized use thereof, by any person or entity, for any reason, whether or not authorized by the applicant, will render the applicant responsible and liable to the Museum for appropriate compensation. Clients failing to return the rented material in useable condition will incur current replacement costs.
4. All final reproductions, unless specifically excepted in writing by the Museum prior to the reproduction, must be smaller than the original work(s) of art, except sculpture.
5. Color proofs and layouts must be submitted and approved prior to publication for cover reproductions, commercial products and other non-art historical usage.
6. The image may not be cropped or bled off the page, nothing may be superimposed on the image nor should it be defaced or altered, and no detail may be reproduced without specific written permission from the Davis Museum.

7. Color slides, color transparency duplicates, monochrome negatives, photographic prints and digital files may not be made outside companies or photographers for commercial purposes.
8. Use in video, film, and digital media or new technologies hereafter devised must be negotiated separately and specific conditions apply. If applicable, a clause governing the intended use will be included on the permission contract.
9. Reproduction ("lifting") from printed, analog, digital formats or any photographic materials not directly supplied to the client by the Museum is strictly forbidden.
10. The Museum reserves the rights, at its sole discretion, to refuse permission for further applications from a publisher or other applicant, if, in its opinion, the standard of reproduction has not been of acceptable quality.
11. To authorize reproduction of works created by living artists, the Museum must receive a copy of the permission obtained by the applicant from the artist or representative.
12. A complimentary copy of the publication must be sent to the Davis Museum, Attention: Registrar's Office.
13. The full credit line as given here must accompany the image: **Davis Museum and Cultural Center, Wellesley College, Wellesley, MA**
